**INSTRUCTIONS: Read this petition carefully and fill in all blank spaces where required.**

1. Petitioner must sign in his/her own handwriting, giving both their residence and post office address, and phone number.
2. The person in whose presence the petition was signed must sign the petition and affidavit before an officer authorized by law to take affidavits.
3. Candidate(s) must sign the CERTIFICATE OF ACCEPTANCE and OATH OF ALLEGIANCE, stating that he/she/they is or are qualified for the office and is or are affiliated with the stated political party.
4. Candidate should contact his/her/their municipal clerk to determine the required number of signatures by municipality and party.
5. This petition must be filed with the municipal clerk not later than 4:00 pm sixty-four (64) days prior to the date of the Primary Election.
6. One or more petitions may be circulated, and one or more petitions may be filed on behalf of the candidate(s).
7. Signers must be qualified voters and reside in the political subdivision for which the candidate stands for office.
8. Each candidate must be registered to vote in the stated municipality.
9. Each candidate is or will be a resident of the municipality at least ONE YEAR PRIOR to the date of the next general election.
