Preliminary Assessment Grant Received For Former "Roadside Rest"



Sandyston Township is in the process of determining the extent of the contamination, if any, of the Road Side Rest/Bischoff property located at 235 Route 206. In December 2022, Sandyston was advised we were approved for a \$6,635.50 grant approved through the Department of Environmental Protection, Hazardous Discharge Site Remediation Program and the New Jersey Department of Economic Development for a Preliminary Assessment of the property to determine location of inground gas tanks and contamination, if any. This investigation is funded 100% through a grant provided by the New Jersey Economic Development Authority.

The Preliminary Assessment was completed in May of 2023 by ADR Environmental. The purpose of a Preliminary Assessment is to gather as much information as possible in relation to the property, the history of the property and documents that might be available in investigating any and all tanks, their location and to move to the next phase "Site Investigation."

In April 2023, Sandyston submitted a Site Investigation grant application in the amount of \$29,442.00. The Site Investigation will look further into the property and pinpoint areas of concern in an effort to determine contamination, if any, to be investigated during the next phase and determine what grants might be available for future tank removal or remediation.

Dog Licenses Required!



Please remember dogs must be licensed at six months old. If you currently have a dog or recently moved to Sandyston and you did not obtain a license—please call the Municipal Clerk.

You may obtain a dog license application at the municipal building or on the Township website:

Remember to provide spay/neuter information & valid rabies certificate with an expiration date of at least November 1, 2022 (per State of New Jersey). Dog licenses fees \$13 unaltered/\$10 altered.

Dog licenses expire in December of each year. Be on the look out for the renewal letter and send your information in as soon as possible to avoid late fees and Court costs.

Tax Bills Mailed

Tax Bills were mailed on Tuesday, July 18, 2023 and you should have received them in the mail. Taxes are due 25 days from the date of mailing (per NJ Statute) which is generally August 1 with a 10 day grace period. The grace period has been extended to August 12, 2023.

For any taxes unpaid by August 13, interest is calculated back to August 1. Any tax payment made will always satisfy the oldest delinquency first, if any, per NJ Statute.

If you recently purchased your home, please allow time for the deed to be recorded with the Sussex County Clerk's Office. If you are selling your home, please provide tax bill to the purchaser.



Sandyston Receives Grants



Sandyston Receives Local Recreation Improvement Grant



On January 5, 2022, Sandyston Township received word we were awarded a \$70,000 Local Recreation Improvement Grant through the Department of Community Affairs, Division of Local Government Services. This grant was for the installation of a walking path behind the municipal building around the ball-field, soccer field and playground and was installed and completed in August 2022. Before receipt of the grant, Sandyston Township Recreation had been working hard to raise funds for this project and funds they have raised to date will be used to supplement this walking path with pavers (see fundraiser) benches and more as ideas materialize and funds are available.

Local Recreation Improvement Grant funds were awarded to successful grant applicants to help cover costs associated with updating community centers, playgrounds, pools, fields, walking or bicycle trails, rail trails, multi-sport courts, and recreational facilities; one-time personnel costs directly related to improvements; project development professional services costs; equipment costs including playground and recreation facilities equipment; and environmental remediation costs required to prepare recreation sites for use. Thank you to Matt Morris of Harold E. Pellow & Associates for his help applying for this grant!

Since the installation of this walking path in August 2022, countless people have enjoyed the new addition to our complex. This has enabled people to have a safe place to walk by themselves or with their children and families, gives parents a place to walk and chat when their children are enjoying a soccer game, baseball game, or time on the playground or a for people to walk safely and at their own speed while recovering from surgeries. We have received an overwhelming number of compliments and gratitude for this newly installed gem.

Remediation Investigation Grant Received For Tri-State Steel Fabricators



As reported in previous newsletters, Sandyston Township is in the process of determining the extent of the contamination of Tri-State Steel Fabricators with a grant approved through the Department of Environmental Protection, Hazardous Discharge Site Remediation Program and the New Jersey Department of Economic Development. In November 2022, our Supplemental Remedial Investigation application was approved in the amount of 75,295.25 to continue our work with ADR Environmental. This investigation is funded 100% through a grant provided by the New Jersey Economic Development Authority. At the conclusion of these investigations, the Township Committee will be provided with costs and steps necessary for remediation, as well as options and grants available for remediation of this site with a possible sale to Green Acres. The investigation is ongoing at this time.



American Rescue Plan Act/LFRF

The federal American Rescue Plan Act of 2021, signed into law on March 11, 2021, was enacted to provide funding for COVID-19 pandemic response and recovery and funds were disbursed from the U.S. Department of Treasury to the State of New Jersey for countries and municipalities called "Coronavirus Local Fiscal Recovery Fund (LFRF)".

Sandyston Township received \$190,810.78 in LFRF Funds in two installments, received in July 2021 and July 2022.

LFRF funds needed to be obligated no later than December 31, 2024 to be LFRF eligible. The period of performance runs until December 31, 2026, to allow for completion of eligible projects. Sandyston Township has utilized these funds as follows:



Assembly Bill 1145, signed into law by Governor Murphy in June 2021, established a State online electronic building permit review and inspection scheduling system, which supplemented and amended P.L.1975, c.217, and amended P.L.2005, c.212, and P.L.1979, c.121, ensuring that electronic permitting systems were implemented to provide a convenient digital experience, secure data and records keeping, and streamlined processing giving residents and contractors the flexibility to file a permit application online with ease 24/7. The Township Committee utilized Coronavirus Local Fiscal Recovery Funds (LFRF) in the amount of **\$34,900.00** payable to **Spatial Data Logic LLC** to improve the Sandyston Township website (ADA accessibility, mobile friendly, providing access to public documents, municipal calendar and audio recordings of meetings), as well as providing online access to Construction Department in an effort to address the negative economic impacts to the municipality as well as investing in technology infrastructure due to COVID-19.

In an effort to address the negative economic impacts to the **Sandyston Township Volunteer Fire Department** due to the decline in income and the lack of ability to fundraise during the COVID-19 pandemic, the Township Committee utilized Coronavirus Local Fiscal Recovery Funds for the donation to the fire department for the purchase of SCBA'S (Self-Contained Breathing Apparatus) as well as to replace outdated, noncompliant hose on several fire trucks owned by the department.

At the time of the writing for this newsletter, the fire department spent \$43,335.00 on the purchase of new SCBA'S (Self-Contained Breathing Apparatus) and the remaining \$6,665.00 was used to purchase new hose for the fire trucks. Many fire departments suffered a decline in income due to the Coronavirus, and these funds gave our department the ability to replace equipment critical to our department and the volunteers.



In an effort to address the negative economic impacts to **Blue Ridge Rescue Squad** due to the decline in income and the lack of ability to fundraise during the COVID-19 pandemic, the Township Committee utilized Coronavirus Local Fiscal Recovery Funds for a **\$50,000.00** donation to the rescue squad for the purchase of an ambulance. Donations were also made by Frankford and Montague Township. The estimated purchase price of the new ambulance is \$174,380.33, a remounted ambulance box onto a new Ford F-450 4x4 chassis— a stripped ambulance without any improvements. As the department adds the necessary equipment the end price will be approximately \$250,000.00.



In an effort to invest in the improvement of water infrastructure through drainage projects on various roads in Sandyston Township, the Township Committee used the Coronavirus Local Fiscal Recovery Funds for the repair of two drains (located on Meyers Road and Old Dingmans Road) to improve stormwater management. The Township Committee utilized bidding procedures as required by N.J.S.A. 40A:11-1 et seq and awarded the contract to **Messercola Excavating Co., Inc.**, on July 19, 2022 in the amount of **\$48,790.00** plus engineering for both projects, with the balance of the funds used for smaller projects and/or engineering.

Pictured to the left is the finished drainage project on Old Dingmans Road. The ability to use the Coronavirus Local Fiscal Recovery Funds for these stormwater issues and have the ability to make the repairs using these funds was a bonus for Sandyston Township.



News and Information



As we travel Route 206 daily, we realize that some sections of this highway are more dangerous than others. This cannot be stressed enough for the section which travels through Stokes State Forest going both north and south on any given day, no matter the time of year. Vehicles travel at a high rate of speed and can be unforgiving of vehicles trying to turn onto Struble Road.

At the request of residents on Struble Road, as well as discussions with fire department members regarding motor vehicle calls, the Township Committee requested the State of New Jersey, Department of Transportation visit this section of Route 206, specifically cars turning off of Route 206 onto Struble Road traveling north and south. The DOT visited this location, available space of the roadway and traffic accident information. Due to the location of a stream on the northbound side of the highway, a turning lane was not possible at the time.. The DOT offered improved signage going north and south alerting drivers of the possibility of turning vehicles as they approach Struble Road. This process took nearly two years to complete and we are appreciative of the cooperation of the Department of Transportation.



Business Insurance Registry

As of August 5, 2022, new State law S-1368 requires all business owners and owners of multifamily rental units to maintain certain levels of liability insurance. In addition, the new law requires that all business owners and owners of multifamily rental units annually register a certificate of insurance with the municipality where the business or rental unit is located.

The owner of a business or the owner of a rental unit or units shall maintain liability insurance for negligent acts and omissions in an amount of no less than \$500,000 for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence. The owner of a multifamily home, which is four or fewer units, one of which is owner-occupied, shall maintain liability insurance for negligent acts and omissions in an amount of no less than \$300,000 for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence. The Insurance Registry is \$10.00 to register and is only valid for a term of one (1) calendar year, and expires on December 31 of the year that the registration was submitted. In the upcoming months, the Clerk will be sending out a letter to all business owners and landlords regarding this new requirement.

Update on Flatbrook Road— Section V Municipal Aid Grant



In October 2021, Sandyston Township was awarded a NJ Department of Transportation, Municipal Aid grant in the amount of \$165,100 for Flatbrook Road Section V. This grant will continue paving on Flatbrook Road where the last project was completed in the Fall.

This project is currently out for bid, with the bid opening date of Thursday, August 3, 2023. Thank you to Harold E. Pellow & Associates, who work on our behalf in applying for the State of New Jersey, Department of Transportation Grants.



Optimum/Altice Brings Cable/Internet



One thing that became abundantly clear during the COVID pandemic is the reality that cable/internet service and connectivity is a major issue in New Jersey. Sandyston Township is no different. While most roads in Sandyston have cable, there are a few roads that still do not and must use satellite or phone for cable and internet—and speeds are dismal at best.

In July 2021, Mayor Harper took these concerns to Altice with the hope that funds we received from the American Rescue Act could be used toward getting cable to the residents of Struble Road. To our surprise, Altice agreed to bring cable to Struble Road at no cost to the residents/municipality. While their projected date of completion came and went, the project was finally completed in March of 2023.

We understand there are a few residents who await the opportunity to be added to the Altice network and we will continue to work with Altice until they are connected.

Sandyston Township Reclassified to Tier B Municipality

In December 2022, Sandyston Township received word the State of NJ, Department of Environment Protection reclassified our township from a Tier B to a Tier A municipality. With this reclassification comes a litany of new rules and regulations and a timeline for their completion. We tried to fight it with many municipalities, but we were unsuccessful.

Through this reclassification, we will need to update stormwater related ordinances, update our website with stormwater information and access to pertinent websites, updated street sweeping regulations, creation of a stormwater pollution prevention plan, MS4 mapping of stormwater inlets and outlets, training for municipal employees and governing body, improved watershed improvement plan, improvements at our DPW yard and more.

To aid our municipality in this daunting task, we have applied for and have been awarded **\$50,000.00 Stormwater Assistant Grant** through the State of NJ, DEP. Upon application we received \$25,000.00 and will receive the additional \$25,000.00 upon approval of our stormwater pollution prevention plan. This grant will help offset the costs associated with this reclassification. Special thanks to Harold E. Pellow & Associates who is helping us with this process.

New Lead Paint Inspection Ordinance

In July 2021, Governor Phil Murphy signed NJ P.L. 2021 chapter 182 into law to require regular inspection of single-family and multifamily residential properties to ensure that people are not being exposed to hazardous lead-based paint in their homes. In 2022, a new policy was enacted by the state outlining further details around “lead-based paint inspections in rental dwelling units” and the critical steps for local government inspections.

The law imposes an obligation on municipalities to perform or hire a certified lead evaluation contractor to perform inspections of certain single-family, two-family, and multiple rental dwellings for lead-based paint hazards every three years or upon owner/tenant turnover where there is no valid lead-safe certification.

The Township Committee is currently working on a new ordinance for compliance of this new law.

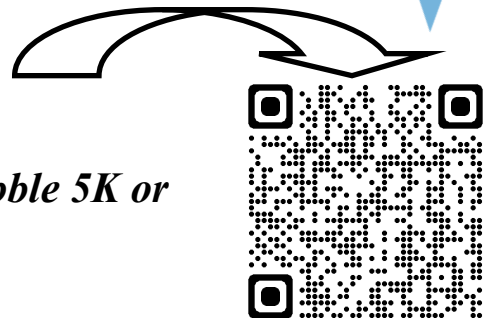

Fire Department News



New Utility Truck for the Department



For many years, the fire department used their 1985 Chevy pick up for nearly 20 years as a brush truck until it was converted into a utility truck to better serve the needs of the department and members on fire calls. The department purchased this vehicle from military surplus almost 25 years ago. In recent years, the truck began to cost the department more money in repairs and fire department members began planning for the replacement of this vehicle.



In March of 2022, a new utility truck, a 2023 GMC Crew Cab with a utility body, was ordered and the department took delivery in December of 2022. Shortly thereafter, lights, radio equipment and lettering was added and fire department members spent many hours preparing the vehicle to get it ready for service to the community. This truck responds to motor vehicle accidents, road closures, traffic details, reports of utility wire fires/wires down and provides transportation of the UTV/Trailer to technical rescues with the ability to carry necessary equipment needed for different types of fire calls.

This purchase was made possible through the hard work of our volunteers and the public support of the department's fundraising efforts and shall serve the community well for many years to come.

Tanker Purchased for the Department



During the summer of 2022, the members of Frankford Township Fire Department contacted the Chiefs of Sandyston and informed them they would be purchasing a new fire truck and asked if Sandyston would be interested in purchasing their Tanker. Being in excellent condition, the fire department members eagerly accepted the offer and in March of this year took possession of the tanker.

The fire department welcomed this new tanker to their fleet which will help with limited water supply within the department, especially during dry conditions.

Thank you to the members of Frankford Fire Department for extending the offer allowing our department to purchase this beautiful truck!

Grant Received from Sussex County Commissioners



On May 10, 2023, the Sussex County Board of Commissioners approved a Volunteer Fire and EMS Equipment Grant Program funded through the American Rescue Plan's State and Local Fiscal Recovery Funds to support Sussex County volunteer fire and emergency medical service organizations by procuring up to \$10,000 per organization for the necessary equipment to run their operations. Volunteer Organizations rely primarily on fundraising, which was impacted sharply by the pandemic, straining capabilities to respond expeditiously to calls, while keeping the volunteers safe with proper, up to date equipment. The fire department applied for a grant in the amount of \$9,800 for the purchase of a TNT Electric Storm Surge Series Combination Tool which will replace the current equipment obtained in 2007 which is gas-powered, heavy to maneuver and not very portable. This combination tool is lighter, easier to maneuver and offers our volunteers improved speed and more versatility when responding to motor vehicle accidents with entrapment or vehicle fires allowing for improved speed in accessing the engine compartment. We thank the Sussex County Commissioners for the opportunity to apply for this much needed grant.

Tax News, Deadlines & Information



Tax Payment Information

- You may reach the Tax Collector by calling 973-948-3520, extension 202. Please call anytime to leave a message and the Tax Collector will promptly return your call. Check the website for days and times the Tax Collector will be in the office.
- Tax payments should be sent to: Sandyston Township, c/o Tax Collector, 133 Route 645, Sandyston, NJ 07826, or you may drop off your tax payments at the Sandyston Township Municipal Building during the tax collectors hours. Checks should be made payable to "Sandyston Township". Please include all tax stubs for taxes you are paying and a return envelope for any papers you wish returned.
- If you wish to pay for your taxes in cash, you must see the Tax Collector directly during her office hours.
- Payments requiring a receipt must be accompanied by the entire tax bill with a self-addressed stamped envelope. The Tax Collector is the only township employee that may issue a receipt for taxes paid.
- Taxes are due February 1, May 1, August 1 and November 1 of each year. Sandyston Township does permit a 10 day grace period. Taxes not paid by November 10 are subject to tax sale.
- All tax payments are due in the tax office on the 10th day by the end of the business day to avoid interest. If the 10th falls on a weekend or holiday, the grace period is extended to the next business day.
- Postdated checks **will not be accepted** and will be promptly returned to the taxpayer. This could delay timely payment of your taxes so be sure to properly date your check.
- Interest on delinquent taxes is 8% per annum on the first \$1,500 of the delinquency and 18% per annum in excess of \$1,500. If delinquent taxes in excess of \$10,000 remain at the end of the year, a penalty of 6% will be charged.
- Absence of a tax bill does not negate your tax responsibilities. Tax due dates never change.
- Did you pay off your mortgage/refinance? If yes, please advise the Tax Collector so the change can be made in our computer system. Use the "Advice Copy" to pay your taxes.
- The Tax Collector is not responsible for any tax payment that is lost in the mail. If by chance your taxes get lost in the mail, you are still responsible for the tax payment and any interest incurred. You may check the status of your taxes online or call the tax collector to check to make sure your tax payment has been received.
- Take a minute and check for any deductions you should be receiving on your tax bill and contact the Tax Assessor should you notice a problem or have a question.
- Please be advised that the State of New Jersey does not allow the Tax Collector to acknowledge postmarks when you mail your tax payment, therefore, taxes must be received in the office on or before the 10th of the month taxes are due. Failure to receive a tax bill does not exempt you from paying your taxes or the interest due on delinquent taxes.
- Make sure your mailing address is correct.
- Before you mail your check, be sure to check it over. Make sure the date, amounts, written word and signature are all in place.

Senior Citizens Annual Property Tax Deduction

Annual deduction of \$250 from property taxes levied on a dwelling house owned and occupied by Senior Citizens age 65 or older; persons permanently and totally disabled; and surviving spouses age 55 or older of an already receiving senior citizen; all of whom must meet the annual income requirement of \$10,000 or less (excluding Social Security/Disability benefits). Applications may be picked up at the municipal building.

Veterans Annual Deduction



Annual deduction of up to \$250 from taxes due on the real or personal property of qualified war veterans and their unmarried surviving spouse/surviving civil union partners/surviving domestic partners.

The veteran must meet all requirements of New Jersey citizenship and legal or domiciliary residence in the State, property ownership, active war-time service in the U.S. Armed Forces, and honorable discharge as of October 1 of the pretax year to receive the deduction for the following tax year. Applications may be picked up at the municipal building and questions can be directed to Kathleen Kieb, Tax Assessor.

Tax Information Available Online

Wondering if you paid your taxes? Was your payment received by the Tax Collector. Now you can get real time tax information anytime of the day by visiting:

Insert your Block/Lot or Last Name (less is more) and get up to date tax information. When using the Street Address option, try to use abbreviations (RD, LN, TRL, ST).

All information provided is subject to verification by the Tax Collector.



Property Tax Reimbursement (Senior Freeze or "Blue Book")

The Senior Freeze Program reimburses eligible senior citizens and disabled persons for property tax on their principal residence. To qualify, you must meet all the eligibility requirements for each year from the base year through the application year (the current application year is 2022).

Applications were mailed in March to the last address you filed with. If you did not receive your booklet, contact our Senior Freeze Property Tax Reimbursement Information Line for assistance at 1-800-882-6597.

Eligibility: You or your spouse were (only one must meet requirement):

- 65 or older on December 31, 2021, or
- Actually receiving federal Social Security disability benefit payments (not benefit payments received on behalf of someone else) on or before December 31, 2021.

P.L. 2023, c75 which was signed into law June 30, 2023, expands the income limit and simplifies the residency requirements for new Senior Freeze program applicants.

Beginning with the 2023 filing season, the law:

- **Increases the income limit for the program to \$150,000 and**
- **Eliminates the requirement that an applicant must be a New Jersey resident for 10 consecutive years.**

Home Ownership: You owned and lived in your home since December 31, 2018, or earlier (and you still owned and lived in that home on December 31, 2022).

Property Taxes: The 2021 property taxes due on your home must have been by paid by June 1, 2022 and the 2022 property taxes must be paid by June 1, 2023.

Applications must be filed by October 31, 2023.

How To Apply:
PTR-1

If you met the eligibility requirements for both 2021 & 2022 and are filing for the first time (or reapplying to the program after being denied in a prior year), file Form PTR-1 and the appropriate verification form (PTR-1A / PTR-1B).

PTR-2

If you filed an application for 2022 and met all the eligibility requirements, file Form PTR-2 and the appropriate [verification form](#) (PTR-2A / PTR-2B). Form PTR-2 is a personalized application that is not available online. If you qualify and have not received this application call [1-800-882-6597](tel:1-800-882-6597) . The verification form is your proof of property taxes due and paid. Alternate documents to send as proof can be found online.

Sandyston Township Offers Many Ways to Timely Pay Taxes

There are many ways to pay your property taxes due to Sandyston Township:

- ♦ US Mail (remember to mail plenty of time before due date and follow up to be sure the taxes were received on time to avoid late fee—postmarks are not accepted per NJ Statute.)
- ♦ Drop off at municipal building either in person or by using drop box (green—secured to building) to the left of the front door.
- ♦ You may make payments online by accessing the township website: www.sandystontownship.com/departments/tax.



There is a 2.965% fee if your payment is made using a credit or debit card and a flat fee of \$1.50 for payments made using an e-check.



Important Information From The Tax Assessor

If your mailing address changes, please notify the Tax Assessor or Tax Collector as soon as possible in writing for the change to immediately take effect. It is very important that the township have the correct and current mailing address for taxpayers so important information can be provided in a timely manner.

If you sell your property, a copy of your tax bill should be given to the new owner. If you need a duplicate tax bill contact the Tax Collector.

To remove a name on your tax record or combine lots, a new deed must be filed with the Sussex County Clerk's Office.

Tax Appeals must be filed with the County Board of Taxation, the Municipal Clerk and Tax Assessor by April 1 of each year. Tax Appeal packets can be obtained by visiting the Sussex County website, under Board of Taxation.

Pool Permits Required! Important Information



In January 2008, the definition of a swimming pool changed. The definition was changed which defines a swimming pool as ANY structure intended for swimming or recreational bathing that can hold 24 inches or more in depth. This includes in-ground, above and on-ground pools, hot tubs and spas.

This definition includes the commonly used “inflatable pool” that is 24 inches or more in depth. Zoning and construction permits are required.

If you recently installed a swimming pool and have not received a Zoning Permit, Construction Permit, necessary inspections and a Certificate of Approval please contact the construction department immediately to avoid violations/fines.

Safety is Priority! If you currently have a permit for a swimming pool, you must contact the Construction Office to schedule your final inspection **BEFORE** you plan on using your pool.

Ladders for above or on-ground pools are very tricky and specific—be sure to talk to the Construction Official before you purchase or to confirm the one you purchase is to code for New Jersey.

Do I Need A Permit??

Contact the Construction Official

Zoning Approval and Construction Permits are required for certain types of installations, remodeling, renovations and repairs around your home. If you are unsure if you need zoning approval or a construction permit, please contact the Construction Department and speak to the Construction Official, Robert Huber, who will provide you with the information and forms necessary.

Zoning approval and construction permits are required for tank installations and removals (propane or oil), deck installation and repairs, additions, remodeling/alteration of rooms, electrical and plumbing work, woodstoves, pellet stoves, gas appliances, sheds, pole barns, air conditioning and generator installation, furnace replacement, water heater replacement, pools (all kinds), hot tubs and more. To be sure a permit is/is not needed please call!

Please remember, realtors and potential homebuyers check for permits to be sure the work was done to code!

Doing the work yourself? That’s great! But if you are using a contractor, be sure to have that contractor fill out, seal (if required) and sign the permit. If you have a contractor, but fill out the permit under your name—you have no recourse should a problem arise!

Your home is a huge investment—be sure to protect your investment and ensure the safety of your family by making sure to take out a permit!

Construction Department Document Imaging



In April of 2023, Sandyston Township Committee approved a contract with “Daida” for the scanning of the Construction files. In May, employees went through over 30 banker boxes of construction files to purge the files and prepare them for the scanning project. At the end of May, Daida picked up these boxes and began the process of preparing the documents for scanning, scanning and indexing the files. With limited space available for storage and



the increased volume of OPRA Requests and the need to access these files quickly, it was decided this would be the best way to preserve the documents, free up much needed space in the vault and give employees immediate access to the records for increased ease in answering OPRA requests and requests from homeowners. Once returned, Sandyston Township will work with Daida to get approval from the Department of Archives and Records Management for the destruction of the construction files upon their approval of the document imaging and our storage of these electronic files.



Are You A Landlord?

Did You File Your Landlord Registration with the Municipal Clerk?

Please be reminded, New Jersey Landlord Registration Act—New Jersey Landlord Identity Law—N.J.S.A. 46:8-27 thru 37, requires landlords who rent (NON-OWNER OCCUPIED) houses, apartments, or buildings to register certain information with the Municipal Clerk of the town where the building is located. You may download a form from the following link:

The form is to be **filed** with the Municipal Clerk and then **distributed** to tenants.

Reflective Markers Required



It is extremely important that emergency services can find your home in cases of emergency. Per Sandyston Township Code, Chapter 47 "Buildings, Numbering of", as well as N.J.S.A 40:23-50, residents are required to have a **VISIBLE** house number by the road for 911 emergencies during daytime and evening hours.

If your mailbox is at the end of your driveway, do you have a reflective marker showing the address? If your mailbox is across from your driveway, do you have a reflective marker clearly visible showing the address? If you have no mailbox, is your property properly marked with a reflective marker showing your address?

If you answered NO to any of these questions, please consider investing in a 911 reflective marker for your property.

****If you live on a private road and the residents mailboxes are all at the end of the road, make sure your physical property is properly marked and is clearly visible. Also be sure your ROAD NAME SIGN is clearly visible.**

Smoke Detector & Carbon Monoxide Alarm/Fire Extinguisher Inspection Required By Law

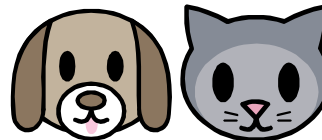


Please be advised, when you sell your home or each time the tenant changes in your rental, you are required to have a Smoke Detector & Carbon Monoxide Alarm/Fire Extinguisher inspection and required to verify the presence of properly dated smoke detectors and carbon monoxide detectors, verifying they are installed and in working condition, as well as verifying the presence of a fire extinguisher near the kitchen. The application fee is:

\$50	10 business days prior to change of occupant
\$80	4 to 10 business days prior to change of occupant
\$125	Giving fewer than 4 business days prior to change of occupant
\$40	Reinspection Fee

Forms are available for pick up at in the Construction Office between 9 am and 2 pm or by calling Teri at 973-948-3520 x201. Information on the requirements on smoke/carbon detectors and fire extinguishers will be provided.

“No National Park” Update



You may be seeing “No National Park” signs around Sandyston Township directing you to a “No National Park” Facebook page, but what does this mean?

In 2014, the Delaware Water Gap National Recreation Area released *Vision 2030: A Vision for a Sustainable Future* outlining their vision of the recreation area. At that time, the Township Committee passed a resolution entitled “R-19-2015 Opposing Specific Proposals of the Delaware Water Gap National Recreation Area “Vision 2030”. One of several proposals was the idea of the Delaware Water Gap National Recreation Area being changed to a park/preserve.

Now, nine years, later that same idea is being pushed by the New Jersey and Pennsylvania Sierra Club’s seeking to change the Delaware Water Gap National Recreation Area to the Delaware Valley National Park and Lenape Preserve. It is important to advise that at this time, there is no formal proposal, there is no information as to the economical, agricultural or environmental impact to Sandyston, the infrastructure, where the “Lenape Preserve” would be located, size or how it will be managed, entry fees charged and how fees would be collected, and more unanswered questions. A change like this would require an Act of Congress and we are aware of no current legislative activity on this matter at the congressional level. But, it is very important that we stay informed on this issue.

Once again, the Township Committee has passed a resolution, on March 22, 2022, entitled “R-26-2022 Opposing the Proposal by the New Jersey and Pennsylvania Sierra Club to Change the Designation of the Delaware Water Gap National Recreation Area to the Delaware Valley National Park and Lenape Preserve Until a Formal Plan is Presented for Public Review and Comment”. We have sent this resolution to our legislators at every level, agencies, municipalities and more to make our voice heard and this resolution served as a model and was passed by surrounding municipalities, county governments, school boards and many outdoor non-profit organizations, farm bureaus, and gun clubs.

The “No National Park” Facebook page has been created by concerned citizens where news and information is made available on their efforts to provide as much information as they can to the public. As always, it is a personal decision where you stand on the issue.

UPDATE: In June 2023, we learned the New Jersey Sierra Club has approved a resolution rescinding the Chapter’s support for redesignation of the Delaware Water Gap National Recreation Area to a National Park and Preserve. We understand from the statement that “members are committed to finding ways to further protect the Delaware Water Gap National Recreation Area and surrounding areas while having indigenous and community voices at the forefront. The Chapter will establish a committee to formalize this work”. Also in June, the Township Committee members sent a letter to the NJ Sierra Club requesting a meeting with them to engage in meaningful conversations regarding what is best for our residents and municipality.

In our letter to the NJ Sierra Club, we questioned how the New Jersey Sierra Club will formulate what they deem is important to the residents of Sandyston Township and communities located in and surrounding the Delaware Water Gap Recreation Area without specifically talking to the elected officials who represent them? Exactly what is the New Jersey Sierra Club looking to protect the Delaware Water Gap National Recreation Area from, what data will be used to formulate these areas of concern and who will be implementing and administering these protections? Who will benefit from these protections and will the use of Eminent Domain be considered? How will the New Jersey Sierra Club consider the inevitable negative impact to our volunteer fire and EMS organizations and the services they provide? As of the printing of this newsletter we have not heard a response from NJ Sierra Club and the Pennsylvania Chapter has provided no change in their stance on the matter.

Thank you to Sandy Hull and the Delaware Water Gap Defense Fund for their steadfast work on this matter.

Voter Registration

Don't Forget To Register!

To register to vote in New Jersey, you must:

- Be a United States Citizen;
- Be at least 18 years of age on or before the next election;
- Be a resident of your home county for at least 30 days before the next election



You may download a Voter Registration form from www.sussexcountyclerk.org, or pick one up in person at the Sussex County Board of Elections office, Sussex County Clerk's office, Sandyston Township Municipal Building or a Motor Vehicle Agency.

Voter Registration form may also be used for name and address changes, signature update, and Political Party Affiliation or Non-Affiliation Change.

Important Dates to Remember

October 17, 2023 is the deadline to submit a Voter Registration for the General Election

October 17, 2023 mandated evening Voter Registration available for General Election in Office of County Commissioners of Registration

October 31, 2023 is the deadline to apply for a Mail-In Ballot by Mail for the General Election

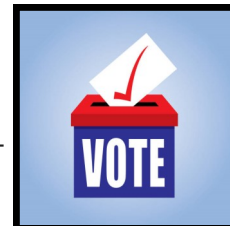
October 28—November 5, 2023

Early Voting At Select Polling Sites

Voters in New Jersey can choose to vote early in the form of Vote-By-Mail or Early In-Person Voting. In person allows voters to cast their votes on voting machines at designated *Early Voting Sites* in their county. The duration of the *Early Voting* period depends on the type of election, with more early voting days allotted to *general* elections than to *primaries*.



- For a **non-presidential primary** there are 3 days of early voting, beginning on the 4th day before Election Day.
- For a **presidential primary**, there are 5 days of early voting, beginning on the 6th day before Election Day.
- For all **general elections**, which are held in November, there are 9 days of early voting, beginning on the 10th day before Election Day.
- The Early Voting period **ends the Sunday immediately preceding Election Day** for all election types.

The number of Early Voting Sites in a County depends on the number of registered voters in the County. Sussex County voters will have a choice of **three** Early Voting Sites:

1. Cochran House Professional Bldg, Newton (parking on Trinity St)
2. Sussex-Wantage Branch Library, Wantage
3. Louise Childs Branch Library, Stanhope

Poll Workers Needed



Sussex County consists of 119 voting districts and employs about 480 Poll Workers for each county-wide election (June and November). The day is usually 15 hours long, and is very rewarding because you are a vital part of the American Democratic process....

The Board of Elections is currently looking to fill positions throughout the county because openings constantly become available due to illness, vacation, or retirement. Poll Workers are usually placed in or near their home town and are paid \$300 per election.
